



Wrecks Change Equipment Rental Program 2010-2011

Program Policies

1. The Lessee individually and as parent or guardian of the skater hereby waives and releases any and all claims for damages for personal injury, including death, arising from the use, misuse, or failure of the leased equipment. Lessee assumes all responsibility for proper fit of the equipment. Lessee acknowledges that skating sports can result in injuries and even death to participants. Lessee hereby assumes that risk.
2. Lease Period: Date of equipment receipt by Lessee until 12 noon April 1, 2011.
3. Program Fees: \$100 Rental Fee for lease period payable at equipment pickup. Optional Additional Purchase Fee of \$100 if Lessee wishes to purchase leased equipment at any time during lease period. Late Fee of \$100 (see #8). Equipment Replacement Charge of \$50 per piece of equipment (see #5).
4. Wrecks Change will provide the Lessee with the following equipment: helmet, shoulder pads, elbow pads, gloves, pants, shin guards, skates, and equipment bag. Provision of the equipment is contingent upon Wrecks Change possessing sufficient stock to meet all requests. If sufficient stock does not exist to satisfy all requests, they will be filled on a first come, first served basis. Other equipment such as neck guards, mouth guards, hockey socks, etc. are not included.
5. Wrecks Change agrees to repair or replace at no charge any piece of leased equipment that becomes unusable as a result of normal usage. Any piece of leased equipment that is lost by Lessee or becomes unusable as a result of improper use or negligence of Lessee will be replaced and a \$50 Equipment Replacement Charge per piece of equipment will be assessed to Lessee.
6. Wrecks Change will provide basic instruction on proper use and care of the equipment at time of equipment pickup.
7. Wrecks Change will provide at least two drop off dates after the conclusion of the season and prior to April 1, 2010 for Lessee to return equipment. Lessee may also make individual arrangements with the Equipment Manager to return the equipment. Such arrangements are the sole responsibility of the Lessee.
8. Failure to return the equipment by April 1, 2010 will result in the assessment to Lessee of a \$50 late fee. Failure to return the equipment by May 1, 2010 will indicate that the Lessee wishes to take ownership of the equipment, and in addition to the late fee, the Optional Additional Purchase Fee of \$100 will be assessed to the Lessee and the entire amount due will be Lessee's responsibility.
